Guidelines for Subject-Specific and Theme-Based Committees

Task No. 294 as per SARTHAQ document

Subject-Specific and Theme-Based Committees have been proposed to implement the NEP 2020 policy recommendations effectively. These committees are structured to ensure focused efforts in foundational, preparatory, and secondary stages of education across different subjects. Below are the detailed guidelines for the formation, structure, functions, and proposals for these committees:

To implement the recommendations of NEP 2020, the following six committees are proposed:-

- 1. Foundational and Preparatory stage committee: (Balwatika to class 2 & class 3 to 5).
- 2. Science Committee: (Class 6 to 12)
- 3. Humanities community: Class 6 to 12)
- 4. Mathematics Committee: (Class 6 to 12)
- 5. Language Committee: (Class 6 to 12)
- 6. Vocational Education Committee: (Class 6 to 12)

1. Proposed Committees and Their Structures

1.1. Foundational and Preparatory stage.

2. Functions of the Committees

- o Implement recommendations provided in NEP 2020 (para 27.1 to 27.3).
- o Document and share the outcomes of meetings, including actionable recommendations.
- Oversee execution of subject/theme-based action plans.
- o Collaborate with relevant stakeholders to ensure timely completion of NEP-related targets.

3. Proposals for a Core Committee

1. Core Committee Role:

- o Coordinate tasks and assignments across all subject-specific committees.
- Monitor progress and compile reports from individual committees.
- Recommend further action plans and ensure implementation.

2. Composition of Core Committee:

- Members from each subject-specific committee.
- Representatives with qualifications and experience in education management.

3. Future Action Plan:

- Develop detailed roadmaps post-approval of proposals by the competent authority.
- Allow committees to form working sub-committees for granular implementation.

The proposed structure and functions of subject-specific and theme-based committees aim to facilitate a cohesive implementation of NEP 2020 recommendations. By integrating expertise from diverse stakeholders, these committees will work toward achieving policy objectives and improving the quality of education in Delhi.
