First participants distributed in 5 person groups and then in 10 person groups to arrive at consensus. It demonstrated that our beliefs limit our rational thinking. It ultimately affects our decision making faculty. Similarly conflicts may arise in school life while dealing with a large number of persons (staff & students). One set of beliefs emphasizes the importance of grades in students' lives but other life skills may equally be important in students' lives.
