The baseline tools for Language 1, Language 2 and Numeracy have been successfully prepared and was followed by piloting in some schools of DoE and MCD. The analysis of the piloting has also been conducted and the changes(as per observations/recordings during piloting) were accordingly incorporated in the baseline tools and replicas.
