## **Guidelines for Nomination of NEP Nodal Teacher (NEP-NT)**

## 1. Purpose of Nomination

To facilitate effective, school-level implementation of the **National Education Policy (NEP) 2020**, each school is to nominate a **NEP Nodal Teacher (NEP- NT)**. This teacher will serve as the **primary facilitator and coordinator** of NEP initiatives within the school, ensuring smooth policy translation from intent to action. The NEP -NT will support alignment of teaching practices, assessment reforms, and curriculum transformation in line with NEP 2020.

## 2. Eligibility Criteria

- A regular, serving teacher with a minimum of 3 years of teaching experience.
- Strong understanding of NEP 2020 vision and reforms.
- Demonstrated leadership qualities, collaborative mindset, and good communication skills.
- Ability to handle documentation, reporting, and digital tools.

#### 3. Preferred Attributes

- Experience or strong interest in the following NEP-aligned areas:
  - Foundational Literacy and Numeracy (FLN)
  - Competency-Based Education and Assessments
  - Multilingualism and Language Education
  - Integration of Vocational Education
  - Use of Experiential and Inquiry-Based Pedagogy
  - Inclusive Education for Children with Special Needs (CWSN)
  - Technology-Enabled Teaching and Learning
  - Integration of Indian Knowledge Systems and Arts
  - Environmental Awareness and Sustainable Practices
  - Promotion of Health, Wellness, and Life Skills

#### 4. Roles and Responsibilities

The NEP Nodal Teacher will:

- Act as the **point of contact** for NEP implementation in the school.
- Facilitate peer orientation and awareness-building activities for school staff.
- Guide the school in integrating NEP's key components such as:

- Holistic, Multidisciplinary Learning
- Flexible Curricular Structures and plans
- Bagless Days and Vocational Exposure
- Critical Thinking and 21st-Century Skills
- Support school leadership in aligning school practices with NEP directives.
- Document progress and submit reports to SCERT/DOE as required.
- Participate in **capacity-building programs** conducted by SCERT Delhi and share learning's with peers.

#### 5. Nomination Process

- A Google Form is circulated to all schools of Delhi (DoE, NDMC, MCD, DCB).
- Each **Head of School** is to nominate **one teacher** per school.
- Ensure that the nominated teacher is **willing and available** to undertake this responsibility.
- Submissions must be made **before the deadline** mentioned in the circular.

#### 6. Final Selection

- All nominations will be **scrutinized by SCERT Delhi**.
- Approval will be granted by the competent authority based on eligibility and recommendations.

#### 7. Importance of the Role

The NEP Nodal Teacher is envisioned as a **teacher-leader and policy ambassador**, who supports the creation of a **joyful**, **inclusive**, **flexible**, **and future-ready school environment**. Their active participation is key to **realizing the transformative goals** of NEP 2020 in every classroom across Delhi
