Subject: Compliance with GAD Circular Regarding Removal of Political References from Official Websites

In reference to the General Administration Department (GAD), Government of NCT of Delhi vide Circular No. 53/718/CN/GAD/2025/61-64 dated 07/01/2025, all DIET Principals, Content Managers, Branch In-Charges, and Nodal Officers etc. working under SCERT/ DIETs in Delhi are directed to ensure compliance with the following instructions immediately:

1. Remove all photographs, messages, and references related to Ministers, Politicians, or Political Parties from the official websites managed by their respective branches/institutions.
2. Review the digital content of the websites thoroughly to ensure compliance with the Model Code of Conduct.
3. Highlight any content that needs removal and inform the WIM, SCERT, immediately for necessary action.

All concerned officers are required to submit an individual undertaking as per the attached standard format, confirming that the necessary steps have been taken for compliance. The signed undertakings must be submitted to undersigned by 09.01.2025 at 3:30 PM positively. Failure to comply with these directions will be viewed seriously.
