Subject: Capacity Building of teachers regarding NIPUN Sankalp (2025-26) Class 2-8.

NIPUN Sankalp is a comprehensive initiative launched by the Directorate of Education (DoE) and State Council of Education Research and Training (SCERT), Delhi to ensure that all children in Classes 1 to 8 acquire foundational literacy and numeracy (FLN) competencies. The initiative is in alignment with the vision of the **National Education Policy (NEP) 2020**, which emphasizes that:

"The ability to read and write, and perform basic operations with numbers, is a necessary foundation and an indispensable prerequisite for all future schooling and lifelong learning." (NEP 2020, para 2.1)

In keeping with this national priority, *NIPUN Sankalp* has been developed to address the existing learning gaps among students and to strengthen the foundational stage of education.

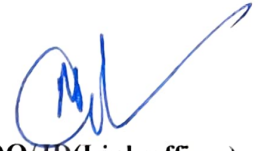
Objectives of NIPUN Sankalp

- To strengthen foundational literacy and numeracy (FLN) skills among all students from Classes 1 to 8.
- To build the capacity of teachers across foundational, preparatory and middle stages with respect to implementation of NIPUN Sankalp.
- To develop and disseminate contextualized, engaging, and inclusive teaching-learning materials aligned with students' learning needs.
- To establish a robust, monitoring and evaluation system aimed at tracking students learning outcomes.

In this regard training of all teachers of DoE Classes 2-5 and 3 teachers (1 TGT English, 1 TGT Hindi, 1 TGT Maths) from each school is being conducted. The training will be conducted district-wise. Which will be coordinated by respective DIETs separately for classes 2-5 (5 Days) & 6-8 (2 Days).

- DDE (Zone) is to monitor the training for the smooth conduct of the training.
- All **Deputy Directors (District)** are requested to provide the list of teachers to the DIETs of their respective districts so that the training can be scheduled in a timely manner.
- All **Deputy Directors (Zones)** are also instructed to direct the Heads of Schools to ensure that the teachers from their schools mandatorily attend the training.

- Duration of training is 5 days (Classes 2-5) & 2 days (Classes 6-8) which will be intimated by the DIET.
