Participant Selection

- District selection: North East district is selected based on the performance of district in NAS 2021.
- 10 schools are selected through randomized sampling through sampling software. (DoE -2, MCD -8) *list of school attached
- You are requested to administer test on minimum 24 students from each class for each subject.

Data Collection Tools

- There is age-appropriate achievement test for each subject (Hindi and Maths) for each class.
- Test booklets and response sheet will be provided to the DIETs by SCERT.

Data Collection Process

- Conduct the data collection in a quiet and comfortable environment to minimize distractions.
- Ensure that the data collector is approachable and friendly to make students feel at ease.
- Begin with a brief introduction about the purpose of the data collection and assure students that there are no right or wrong answers.
- You are requested to administer the both subject tool to same students and fill the response sheet.

Data Recording

- Fill the google form from response sheet answers. Google form will be provided at the end of the data collection.
- Record responses accurately and without bias.

Data Management

- Organize and store collected data in a secure and confidential manner.
- Keep hard copies of the data in a designated storage space and sent to SCERT Delhi
