I am directed to refer to the Ministry of Home Affairs, Government of India, letter no. 13028/30/2021-Delhi-I, Dt. 01.04.2024 (copy enclosed), wherein, the MHA, GoI has agreed to allow one notional increment on 1st July/1st January to such eligible employees of Government of NCT of Delhi who retire from service on 30th June/31st December, respectively, for the purpose of calculation of pensionary benefits, in respect of those employees only who fulfill all other conditions of qualifying service etc. for grant of such increment.
