**NOTIFICATION**

In exercise of powers conferred by sub-rule (ii)(c) & (d) of rule 43 of Rules and Regulations of the State Council of Educational Research and Training, Delhi, the Executive Committee of the Council do hereby amends (i) SCERT Delhi Academic Post(Assistant Professor) SCERT & DIET Amendment Regulation 2020, and (ii) SCERT Delhi Academic Posts ( Professor, Associate Professor, Principal- B.Ed, Principal & Vice Principal- DIET) SCERT & DIET Regulation 2020 as under:-

**1. Short title and commencement :-**

- (i) These Regulations may be called the SCERT Delhi Academic Post (Assistant Professor) SCERT & DIET Amendment Regulation 2022, and
- (ii) SCERT Delhi Academic Posts (Professor, Associate Professor, Principal- B.Ed, Principal & Vice Principal- DIET) SCERT & DIET, Amendment Regulation 2022
- (iii) These shall come into force with effect from the date of Executive Committee Meeting i.e. 05.07.2022.

**2. The amendment shall be as under:-**

- (i) The discipline in which NET Qualification or the subject in which Ph.D is required in lieu of NET Qualification for the post of Assistant Professor shall be in the discipline of "Education" Only except in cases of Assistant Professor (Fine Arts) and Assistant Professor (Health & Physical Edn)
- (ii) The discipline of Ph.D. for the post of (a) Professor, (b) Associate Professor, (c) Principal- B.Ed, and (d) Principal & Vice Principal- DIET shall be in the discipline of "Education" Only except in cases of Associate Professor( Fine Arts) and Associate Professor ( Health & Physical Education).


