Subject: Nomination for Resource Support Group for effective implementation of Entrepreneurship Mindset Curriculum in Delhi Government Schools

Entrepreneurship Mindset Curriculum is in its fifth year of implementation in Delhi government schools. As the operations become imbibed in the school system through the efforts of various stakeholders, it is now time to further enhance its implementation with more focus on the mindset development and developing of core entrepreneurial skills and abilities among students. To fulfil this vision of enhancement of entrepreneurship capabilities, the State Council of Educational Research and Training (SCERT), Delhi is setting up a Resource Support Group (RSG) for Entrepreneurship Mindset Curriculum.

The Resource Support Group (RSG) will be a body composed of different educators - heads of schools, mentor teachers, teachers, EMC coordinators, and all those who would want to passionately work towards forwarding EMC and becoming the harbingers of change, innovation and entrepreneurial movement among students and teachers across the state.

The role of the Resource Support Group will be to -

- Nurture and develop 100 model schools where EMC implementation is of the highest quality
- Co-design and facilitate monthly sessions on key entrepreneurship mindsets, skills and concepts in the model schools.
- Develop and share best practices learnt from interactions with the core EMC team and the external resource persons.
- Promote entrepreneurship in their zones/ districts through events/sessions/other initiatives.
- Support the Core EMC team is planning for overall better implementation of EMC on ground.

The Resource Support Group will have regular capacity building on -

- Theme based workshops with SCERT.
- Problem solving and solutioning exercises from ground experience.
- Training on various entrepreneurial aspects by reputed institutes.

To further the cause of the group and better implementation of EMC, the responsibilities of the Resource Support Group will be to -

1. Take ownership of mentoring 3-5 schools on EMC from the sample.

2. Hold regular interactions with the Head of School/ EMC Coordinator and Teacher.
3. Observe 3-4 EMC classrooms in a month.
4. Devote 5-7 days per month for overall self and school capacity building on various entrepreneurship concepts.

Eligibility:

- All applying members should be regular teachers of DoE.
- They should be interacting with EMC in different capacities since atleast the last two years
- They should have three years of service left as on 1st August 2023.

SCERT, Delhi is inviting applications from passionate changemakers who would like to join this drive to not just create but also become innovators in Delhi's education system. All eligible teachers, Mentor Teachers, EMC Coordinators and Heads of Schools can apply to become a member of the RSG. There will be no additional remuneration for joining the group.
