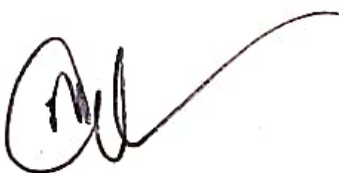

This issues with the prior approval of Director, SCERT.



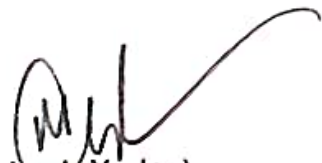
