- 2. No extra remuneration will be paid to the staff of SCERT.
- 3. No honorarium will be paid to staff & employee of SCERT.
- The remuneration is subject to maximum ceiling of Rs.5000/- per day per RP excluding transportation charges.
- 5. No transportation charges would be payable to the faculty using official vehicles.
- Outstation faculty who comes to deliver lecture on his/her official tour will not be paid any transportation charges.
- Outstation faculty excluding NCR districts will be paid transportation charges on A.C II
 tyre by train or Economy class by Air of the actual expenditure on the class of journey
 chosen for travel, whichever is lower, on production of original boarding passes in case of
 Air journey.
- TDS applicable as per rules will be decided for the remuneration/honorarium paid to Faculty.
