ORDER

Subject: Implementation of Hon'ble High Court Judgment in W.P.(C) No. 16740/2022.

In compliance with the judgment of the Hon'ble High Court of Delhi in W.P.(C) No. 16740/2022 (Rajani Saini & Ors. vs SCERT), the following is hereby ordered:

1. **Grant of Extension:** - All Non-Qualified Candidates who do not possess the requisite qualifications shall acquire the same within one year from the date of judgment and accordingly all concerned petitioners are granted one (01) year time from the date of judgment to acquire the requisite qualifications as per applicable Recruitment Rules.
2. They are required to submit documentary proof of acquiring the requisite qualifications for the post of Asstt. Professor of the discipline in which they were working before their termination of service due to non- fulfilment of educational qualifications, within the stipulated period, failing which their candidature/engagement shall be liable to be termination.
3. **Consideration of Eligible Candidates:-** Those petitioners who have already acquired the requisite qualifications shall be considered for continuation of their engagement to the post of Lecturer (on contract basis), subject to verification of documents and fulfilment of eligibility conditions.
4. **Verification of Documents:** All candidates shall be required to submit their educational qualification certificates and supporting documents for verification and their continuation shall be strictly subject to successful verification.
5. Rest of the Terms and Conditions of appointment shall remain the same as were applicable to them at the time of termination of their service. Eligible candidates shall be considered on the same terms and conditions as applicable to those appointed earlier vide order dated
6. **Compliance Timeline:** All necessary action shall be completed by the eligible candidates within 01 week from the date of issuance of this order failing which the offer would automatically stand cancelled without further notice.

This issues with the approval of the Competent Authority.

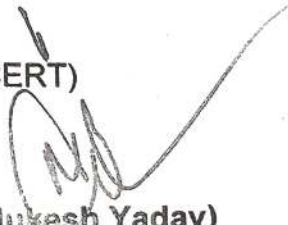
