

NOTICE

On the recommendation of RR Committee, SCERT Delhi proposes to amend Recruitment Rule of the various academic post for which RRs have already been notified, as under:-

1. The RRs of the post of Professor may be amended with regard to mode of appointment from Direct Recruitment to Appointment by way of Deputation/ Direct Recruitment only.
2. The eligibility given in clause 4.1(III)(A) of UGC Regulation 2018 shall only be applicable subject to followings and recruitment rules to the post of Professor may be amended as under:-
 - a) A minimum of 03 years experience as Associate Professor in pay-scale of Rs PB-4, AGP 9000 (Level- 13A) in a Central/State Govt., University/College/ Teacher Education Institution/ Autonomous bodies.
 - b) For appointment on deputation, the person must hold either the analogous post OR holding the post of Associate Professor in pay-scale of Rs PB-4, AGP 9000 (Level-13A) in a Central/State Govt. University/College/ Teacher Education Institution/ Autonomous bodies, for a minimum period of three years and fulfilling other educational qualifications and experience meant for direct recruitment.
3. The 10 years experience as per UGC regulation 2018 under experience clause in the existing RRs shall be amended as a minimum of 10 years of teaching experience in a Central/State Govt. University/College/ Teacher Education Institution/Autonomous Bodies. The requirement of research publications and total research score shall remain as per UGC Regulations 2018, as amended from time to time.

4. For the NET/Ph.D. shall be in Education only for all the posts/disciplines
5. For academic and professional excellence, the equivalency of M.Ed. with MA(Edn) plus B.Ed be done away with and only qualification of M.Ed. shall be applicable for all the posts/disciplines.


Rest of the provisions of the notified RRs shall remain unchanged.

Accordingly, the proposed amendments in the RRs are hereby placed in the public domain for perusal of stake holder and submission of their comments, if any, within 15 days from the date of issue of this circular.

The stake holders may submit their comments, if any at the following dedicated email ID only, within 15 days from the date of issue of this circular. Comments received through any other mode, shall not be entertained.
