

TENDER NOTICE

PROCUREMENT OF PRE-SCHOOL KITS FOR SCERT, DELHI

(E-Procurement)

E-Tenders in two-bid System are invited from registered firm for supply of Pre-School Kits for SCERT, Delhi for the financial year 2021-22. The terms & conditions and details of the items to be supplied are described in the Tender Document.

NAME OF THE WORK: : SUPPLY OF PRE-SCHOOL KITS UNDER DIFFERENT SAMAGRA SHIKSHA(SS) SCHEME of DELHI FOR SELECTED SCHOOLS OF LOCAL BODIES AND DoE, DELHI FOR THE FINANCIAL YEAR 2021-22.

Important details:

1. SCERT, Delhi; invites e-tenders from the intending and eligible manufacturer/registered firm for procurement of Pre-School Kits for **Selected schools of local bodies and DoE, DELHI**. The bidders are hereby requested to carefully read the instructions and other clauses furnished herein below before they prepare and submit/upload their tenders.
2. **Schedule of Tendering:**

Bid submission End date: 17.01.2022 at 11.00 AM

Bid opening date: 17.01.2022 time : 12.00 PM
3. Tender documents may be downloaded from the official website www.scertdelhi.nic.in. The Tenders should be submitted through e-procurement system only except for an original copy of crossed Demand Draft/ Banker's Cheque/ Online Payment Proof/ Fixed Deposit Receipt (FRD)/ Bank Guarantee for Tender Fee and EMD.
4. The bid document can be downloaded from <https://govtprocurement.delhi.gov.in/> and www.scertdelhi.nic.in
5. The Bidder shall upload their bid with all required document (Annexure-1 to 6) and scan copy of EMD submission proof on-line on the website <https://govtprocurement.delhi.gov.in/>.
6. The tender should be uploaded online before the scheduled date and time of uploading/submission.
7. Total value of the work Rs. 3.20 Crores approx.
8. The bidders shall have to submit the proof of payment of EMD @ 2% of the total value of the work i.e. Rs. 640000/- only in the form of crossed Demand Draft/ Bankers Cheque/ FDR/ of any Nationalized Bank/ Scheduled Commercial Bank that should be payable at Delhi only.
9. The EMD of unsuccessful bidder will be returned within 30 days of bid finalization.
10. The Original copy of EMD in the form of crossed Demand Draft/ Banker's Cheque/ FDR/ E.M.D. along with other relevant documents should be submitted/deposited to the SCERT, Delhi, in favour of Director, SCERT, Delhi in a sealed cover on or before the last date and time of submission of tender. The cover should be superscripted with the details of the tender.
11. The registered firm must mention their full postal address of their registered office with phone number (landline or mobile as the case may be) and the e-mail id. More than one address shall not be entertained. No sub / additional addresses will be accepted.
12. To participate in this tender process through e-procurement, the bidder should have valid Digital Signature Certificate (DSC) of Class-III signing and have to register in the portal <https://Delhitenders.gov.in> by themselves.
